THE UNDERSIGNED

1. Has asked NORTHERN FRONT PAINTBALL CLUB to be allowed to play the game of paintball and acknowledges that the game involves physical exertion and may result in injury to the undersigned or others playing the game.
2. Is aware of the possibilities of risks of injury, including, but not limited to being shot by a paintball, falling, tripping, being hurt by a wild animal, snake bite, heat stroke, heart attack, hypothermia, getting lost in the wilderness, being shot by hunters, insect bites & stings, poisonous plants, and improper use or operation of equipment by the undersigned player.
3. Agrees to play the game according to the rules which have been explained and to follow the directions given by the game referees.
4. Warrants and acknowledges that his or her physical condition is excellent and his or her mental state is sufficiently stable to enable him or her to participate safely in game.
5. Agrees to use any paintball equipment in a manner which will not cause injury or damage to himself or herself or other players.
6. Certifies that he or she is over 14 years of age.
7. Authorizes use of photos, videos, name, comments, game results, etc. for promotional uses.

IN CONSIDERATION of being permitted to play the game, the undersigned, on behalf of himself/herself, his/her successors or assigns, hereby release and forever discharges Northern Front Paintball Club, land owners, land lease holders or managers, and their successors, assigns, employees, officers, agents and franchisees, dealers, or operators both jointly and severally, from any and all actions, covenants, claims and demands for damages, costs, loss or injury, however arising, including negligence of Northern Front Paintball Club which may have been sustained by the undersigned in any way relating to or arising out of playing of paintball or the equipment, including but not limited to, the manufacture, selection, delivery, possession, use, or operation of the equipment or the natural environment. The undersigned desires and agrees to assume any and all risks.
